H.R. 921: The Sports Medicine Licensure Clarity Act

This bill provides legal protection for athletic trainers and sports medicine professionals who travel to other states with an athletic team to provide care for that team. Allow athletic trainers and sports medicine providers to engage in the treatment of injured athletes across state lines without the fear of incurring great professional loss. These bills aim to preserve sports athletes and athletic teams' access to sports medicine professionals who provide high-quality health care services.

Great news coming from the capital. H.R. 921 was passed by the House Energy and Commerce Committee. The next step for H.R. 921 is to go to the House of Representatives for consideration if it is approved in the House it will travel to the Senate for approval as well. If the Senate approves the bill it will go to the president for signature and then it will become a law.
